## Liability Waiver / Hold Harmless Agreement – 2009

We ask your cooperation, as a contestant, to abide by the rules set forth herein to achieve for all of us, in the sport of "Cowboy Action Shooting", a fun and safe event.

1. Alcohol is not permitted on the Pawnee Station range at any time. If a violation occurs, you will be asked to leave the premises. No drugs are allowed on any part of the range. Use of any type or form will mean disqualification of the shooter and automatic removal from the range.
2. No loaded firearms behind the firing lines, or in the spectator's area. Guns are to be loaded and unloaded in designated areas only. Rifle and shotgun actions will remain open until they are loaded. Pistols will remain in holster until you are on the firing line. No gun handling behind the firing line. We are shooting on cold range rules.
3. Safety glasses must be worn at all times by participants and spectators. Hearing protection is strongly recommended.
4. Firearms and ammo restrictions: Only Single Action revolvers, Lever Action Rifles of .32 caliber or larger, double barrel (side by side)shotgun, 97's and lever action shotguns are OK. No ejectors allowed on double barrel shotguns, no jacket or gas checked bullets allowed. Dress must be old west. No tennis shoes, T-shirts, ball caps, etc.

I understand that I am participating in a sport, in which certain dangers and risks may arise, including, but not limited to, accidental injury, the forces of nature and illness. In consideration of the right to participate in this event, and the service provided me by the Pawnee Station Cowboy Action Shooting Club; I hereby release Pawnee Station; its officers, its directors; and its agents from all liability that results from damage or injury occurring either to myself or to a member of my family or my guest during the use of the facilities or our presence thereon. Without limiting my wavier and release in any fashion or manner, I specifically release Pawnee Station; its officers, its directors, and its agents from any and all causes of action or claims from compensation without regard as to whether such cause of action or claims for compensation lie in tort; contract; or otherwise. I further release Pawnee Station from liability for any and all consequential damages that accrue to me or my family on the account of, or growing out of, our use of the facilities or in participation in any Pawnee Station event no matter where such event may occur. I have and do hereby assume the risks associated with such events. The contestant shall, at his own expense, defend management and/or all sponsors, their members, or employees from all such claims and indemnify, from any and all liability, damages and cost arising from injury to persons or property occasioned by any act or omission of the constant.
